Re: Show Cause Notice for declaring M/s.Supreme Coated Board Mills Pvt Ltd. and its Directors/ Guarantorsas Wilful Defaulters and Opportunity for Representation there against.
 We refer to your captioned account and write to inform you that due to non-payment of interest/instalment, account turned to Non-Performing Assets in the books of the Bank on **30.04.2014.**
 We further write to inform you that as per the directions of the Committee of Executives on Wilful Defaulters of our Bank and on scrutiny of your account based on your acts of omission and commission, deeds/ documents and writings, performed /executed by the Company and its directors/guarantors, the Company and its directors/guarantors be classified as Wilful defaulter as per guidelines of RBI on the following grounds:
 1. Payment made to certain parties even though there is no amount due to them or any other transaction with them during 2017-18 and 2018-19 to the extent of Rs.1.93 Cr.
 2. During 2018-19 entries to the extent of Rs.3.75 Cr. has been capitalized to transfer to Creditors Ledger without any supportive documents indicating siphoning of funds.
 3. Advances to suppliers' accounts in earlier years capitalized. Individual suppliers to whom it has been given and the names not available to the extent of Rs.1.26 Cr. and Rs.0.40 Cr. during 2018-19.
 4. Trial run expenditure to the extent of Rs.17.40 Crores passed on a single day i.e., 31.03.2018 has been capitalized without any production of record and write off of stocks to the extent of similar amount without justifiable production record, without capitalization of other overheads, raising of invoice on A V Thomas and Co Ltd without corresponding entry in the books of CD clearly shows the siphoning of funds by the Company in a discreet manner.
 5. Paripaasu charge has been created on the assets of Unit 2 /for Rs.2600 Lakhs favouring City Union Bank Limited without obtaining NOC from the other lenders belatedly in Dec 2018 i.e., 2 years after sanction of the limits of Rs.18 Cr. in Sept 2016 and Rs.8.00 Cr. in May 2016 though it was stipulated only for the limit of Rs.8 Cr. and that too after obtention of NOC. By act of which, the City Union Bank Limited will have a beneficial position over others in distribution of assets under IBC thereby the security is diluted.
 6. Though there was no operation in the company post Oct 2018 an amount of Rs.0.61 Cr. has been credited as pre-operative expenses into the vendors accounts.
 The Company has defaulted in meeting its payment/ repayment obligations to the lender and has diverted/siphoned off the funds so that the funds have not been utilized for the specific purpose for which finance was availed of, nor are the funds available with the firm/company in the form of other assets.
 In terms of RBI guidelines and to comply principles of natural justice, if you, desire, you may send your submission for consideration by the Committee of Executives, headed by our Executive Director within -15- days from the date of receipt of this letter as to why your account and you be not classified by Bank as a Wilful Defaulter. The Committee reserves the right to give or not to give the personal hearing to decide about classifying as wilful defaulter in case your submission is received.
 Please note that, in case your submission against the intention of Bank to declare you as a Wilful Defaulter is not received within -15- days from the date of receipt of this letter, the Bank will proceed further and classify your account as wilful defaulter. Bank reserves the Right to publish the name and photograph of Wilful Defaulter in News Paper and will initiate the necessary recovery action as per extant guidelines issued by Reserve Bank of India.
