1. Notes to the financial results:

1. The above unaudited standalone financial results were reviewed by the Audit Committee and approved by the Board of Directors of the company at the meeting held on August 14, 2018. The above results were reviewed by Statutory Auditors.

2. The Company's main business is manufacture and sale of plain shaft bearings. There is no other reportable segments.

3. Post the applicability of Goods and Service Tax (GST) with effect from July 01, 2017 revenue from operations is disclosed net of GST. Accordingly, the revenue from operations for the quarter ended June 30, 2017 are not comparable with the subsequent period results.

4. The Company has adopted the new revenue accounting standard 'Ind AS 115 - Revenue from Contracts with Customers' with effect from April 01, 2018. Based on the assessment carried out, there is no material impact consequent to the adoption of new standard.

5. The Company has assessed the impact of amendment to Appendix B to 'Ind AS 21-The Effects of Changes in Foreign Exchange Rates', effective from April 01, 2018 in respect of advances received and paid in foreign currency, and noted no material impact.

6. The figures for the quarter ended March 31, 2018 are the balancing figures between the audited figures for the year ended on that date and the unaudited year-to-date figures for the period ending December 31, 2017 which was subject to limited review.

7. Previous period figures have been regrouped/reclassified wherever necessary.
