3. The Company's main business is manufacture and sale of plain shaft bearings. There is no other reportable segments.

4. Post the applicability of Goods and Service Tax (GST) with effect from July 01, 2017, revenue from operations is disclosed net of GST. Accordingly, the revenue from operations for the quarter/ year ended on March 31, 2018 are not comparable with the previous periods presented in the results.

5. The figures of the last quarter are balancing figures between the audited figures in respect of the full financial years and the published year-to-date figures upto the third quarter of the respective financial years.

6. Previous period figures have been regrouped/reclassified wherever necessary.

7. The board has been a dividend of 90% for the financial year ended 31st March 2018.
