The Company has claimed the damages with insurance company and received Rs. 411.51 lakhs before the year end and balance Rs. 16.77 Lakhs had been accounted as recoverable, Rs. 12.94 (net of tax expenses) lakhs losses shown as extra-ordinary items.
- 5 The business activities reflected in the above financial results comprise of manufacture and sale of plain shaft Bearings. Accordingly, there is no other reportable primary business segment as per Accounting Standard 17(Segment Reporting).
- 6 The Previous period figures have been re-grouped/reclassified wherever necessary to conform to the classification for this quarter.

To the Members of Bimetal Bearings Limited

Report on the Standalone Financial Statements

1. We have audited the accompanying standalone financial statements of Bimetal Bearings Limited ("the Company"), which comprise the Balance Sheet as at March 31, 2016, the Statement of Profit and Loss, the Cash Flow Statement for the year then ended, and a summary of the significant accounting policies and other explanatory information.

Management's Responsibility for the Standalone Financial Statements

2. The Company's Board of Directors is responsible for the matters stated in Section 134(5) of the Companies Act, 2013 ("the Act") with respect to the preparation of these standalone financial statements to give a true and fair view of the financial position, financial performance and cash flows of the Company in accordance with the accounting principles generally accepted in India, including the Accounting Standards specified under Section 133 of the Act, read with Rule 7 of the Companies (Accounts) Rules, 2014.
